

LAKE SAINT LOUIS Violations Bureau

Per Missouri Supreme Court Rule 37.49, and as Municipal Judge of the City of Lake Saint Louis, St. Charles County, State of Missouri, I do hereby establish by Judicial Order a Violations Bureau, which shall be subject to the supervision of the St. Charles Circuit Court.

It is hereby ordered that Mary Vance, Court Administrator is appointed Violation Bureau Clerk. It is further order that the Court Administrator can designated Court Clerks and Administrative Assistants to perform the duties required by the court including accepting appearance, waiver of trial, plea of guilty, and payment of fine and costs in animal control, housing violation or traffic offenses.

The offenses within the authority of the violation clerk are hereinafter designated along with the fines and court costs to be imposed by Order Of This Court.

**Any violation involving an Accident requires a court appearance.
Anyone 17 years or younger must appear in court with a parent or legal guardian.**

In all of the below listed cases, costs will be assessed at \$29.50 unless otherwise noted.
This schedule of fines and costs are subject to change due to any change in state or local laws.

SPEEDING (Maximum paid through VB - 18 miles)

1 mph-10mph over the speed limit is \$3.00 per mile + .50 + \$29.50
 11 mph-18mph over the speed limit is \$4.00 per mile + .50 + \$29.50
 19 mph and over requires the defendant to appear in court (with some exceptions)
Speeding in a "Construction Zone", "Special Enforcement Area" and "School Zone" may carry additional penalties, please contact the court clerk's office.

Any payments made at or through the Violations Bureau including Online shall constitute a guilty plea and the waiver of a trial.
