AN ORDINANCE ESTABLISHING THE ANNUAL TAX RATE FOR THE YEAR 2022 ON ALL PROPERTY IN THE CITY OF LAKE SAINT LOUIS, ST. CHARLES COUNTY, MISSOURI AND ESTABLISHING A NEW ORDINANCE ON THE SAME MATTER.

Be it ordained by the Board of Aldermen for the City of Lake Saint Louis, Missouri as follows:

SECTION 1. In accordance with Section 137.073, RSMO, and the results of the vote of the people at a November 8, 1988 election, there is hereby levied on all real property within the corporate limits of the City of Lake Saint Louis, Missouri a tax rate of forty-seven and 11/100 Cents (\$0.4711) on the one hundred dollars (\$100.00) assessed valuation as shown on the assessment books of the St. Charles County Assessor, as corrected or amended by the Board of Equalization and certified by the County Clerk for the taxable year 2022.

SECTION 2. The Clerk of the County of St. Charles, Missouri is hereby authorized to extend on the books of the Collector the amount of taxes due and collectible according to the above tax rate of 47.11/100 cents (\$0.4711) on the one hundred dollars (\$100.00) assessed valuation, on all real property within the corporate limits of the City of Lake Saint Louis, Missouri.

SECTION 3. The Collector and/or any deputies who may be appointed for the City of Lake Saint Louis are hereby authorized to collect taxes so extended by the Clerk of St. Charles County and due to the City of Lake Saint Louis, and the collection of all taxes shall be enforced in the same manner and under the same rules and regulations as may be provided by law for the collection and enforcing the payment of State and County taxes.

SECTION 4. All other ordinances or parts of ordinances contrary hereto are hereby repealed.

SECTION 5. This ordinance shall be in full force and effect from and after its passage and approval.
